	 11.08.2025	Present Sri Sumir Bag Judicial Magistrate First Class <u>Kanchanpur::North Tripura</u> The instant case record is put up today upon receiving a put up petition filed by Ld. Advocate Mr. Joy Saha. Received the supplementary case record from Ld. SDJM, Kanchanpur, North Tripura wherein is mentioned that the A/P was arrested and took a bail from the Ld. Court. Perused the same and tag the same along with the case record. Ld. APP Sri Nirmal Das is present. Ld. Counsel Mr. Joy Saha has appeared before this court along with the accused Sri Dinesh Kumar Reang and has filed a guilty plea petition followed by vokalatnama. Perused the petition. Tag the same along with case record. Heard and considered. Supply a copy of Challan to the A/P. Substance of accusation is orally stated to the accused who is present before this Court today. Perused the case record. From the case record, it appears that some foreign/country made liquor has been seized and these are (which are mentioned in seizure list) as follows: 1. 84 nos of KD containing 750 ml in each bottle. 2. 60 nos of Kingfisher beer containing 750 ml in each bottle. 3. 240 nos of Kingfisher can beer containing 500 ml in each bottle.		

		Regarding guilty plead petition, this Court is prima facie satisfied that the accused has pleaded guilty voluntarily. Therefore, this Court sentenced the accused to pay fine of Rs. 10,000/- in default to simple imprisonment for 04 days. Ld. Advocate Mr. Joy Saha has verbally submitted that A/P is economically poor and lives on hand to mouth, therefore he is unable to pay Rs. 10,000/- and is able to pay of Rs. 2,000/- only. Ld. APP has prayed for passing necessary order in this regard. Heard and considered. Having regard to the submission of both Ld. APP and Ld. Defence Counsel, this Court is receiving the fine money Rs. 2,000/- and in default of payment of rest amount A/P is to suffer simple imprisonment till rising of this Court. The accused/ Engaged Counsel is advised to submit the fine either through Online Mode https://pay.ecourts.gov.in/epay/ or through Offline Mode by way of Challan.		
	As dictated Later On,	The accused has submitted the fine money amount of Rs. 2,000/- through offline mode which has been realised vide challan no. 1340684, dated 11.08.2025. Accused Sri Dinesh Kumar Reang is hereby released after expiry of simple imprisonment till rising of this Court. Send the realised fine money of Rs. 2,000/- to the Nazir/Cashier of this establishment for depositing the same to the State Treasury. Mark a copy of this order to the Nazir/cashier of this establishment. This case is thus disposed of without contest.		

		The seized articles are not lying with Court Malkhana. So, CTI of Kanchanpur Police Court is directed to take appropriate step and to make communication with IO for handing over the same to the local Excise Authority for disposal of the same as per law.
