Separate applications for exemption from personal appearance filed on behalf of accused Gurmeet, Paramjit Singh, Inderpal, Simaranjeet. Sandeep, Partap, Anoop and Jagdeep, Hari, Akash Saini, Gurpreet Singh, Ajay, Anoop, Gurpreet. Heard. Keeping in view the circumstances mentioned in the application, personal appearance of accused persons are exempted for today only.

PW34 Kapil Sharma, PW35 Pankaj Goel, PW36 Rajinder Parsad are present and examined. No other PW is present.

Thereafter, learned PP for the State has given up PW Karan Singh being unnecessary. Vide separate statement recorded today, the Ld. Public Prosecutor on receiving the death certificate Ex.P-DH forwarded by SHO PS Sector-14, Panchkula. In view of the above-said report and certificate, I deleted the name of PW Karan Singh from the list of witnesses being died in view of the death report.

Now to come up on 11.08.2026 for prosecution evidence. All remaining unexamined Pws be also summoned for the date fixed.

Production warrants against the accused Deepu be issued in the name of concerned Jail Superintendent for the date fixed.

Reply to application for seeking permanent exemption from personal appearance on behalf of accused Partap Singh S/o Asha Ram not filed.

With a view to ensure expeditious progress of the trial and strict compliance of judicial directions, the ACP, Headquarters, Panchkula is directed to personally supervise the execution of summons/warrants issued to the prosecution witnesses. The concerned SHO/Incharge of summoning staff shall also ensure the presence of all prosecution witnesses on the next date of hearing, failing which the defaulting officer(s) shall remain personally present before this Court to explain the lapse.
