This petition for bail coming on this day for hearing before me, M/s.T.Anto Chrisbeen Jenitha, the learned counsel appearing for petitioner/accused and M/s.R.Thirumurugan, the learned Public Prosecutor appearing for the respondent/complainant upon hearing both sides and upon perusal of case records, this Court made the following

**ORDER**

This petition is filed by the petitioner/accused U/s.483 of BNSS 2023, seeking to enlarge the petitioner on bail.

2. The petitioner/accused is facing charges for the alleged offences U/s.309 of BNS, 2023.

3. Notice given to the Public Prosecutor for the State and the reply received. Heard both sides. Records are perused.

4. The case of the prosecution is that the defacto complainant and the other victims are working in a construction site. On the occurrence day, the petitioner along with other accused trespassed into the construction site, threatened the victims and snatched a sum of Rs.500/- through online transfer and fled away. Thereby FIR has been registred in Cr. No.80 of 2026 on the file of respondent Police Station.

5. The learned counsel for the petitioner would submit that the petitioner is an innocent, no way connected with the offence; he was arrested and remanded on 08.03.2026 and he is under judicial custody for the past 10 days; the petitioner is ready to abide by any conditions to be imposed upon him and he is ready to offer substantial sureties before the Court, thereby prayed for enlargement on bail.

6. The learned Public Prosecutor, on the other hand, would re-iterate the prosecution case and prays for the dismissal of the petition. He would further submits that the petitioner is not involved in any other cases.

7. From the submissions and records it is seen the petitioner is in judicial custody for the past 10 days. He seemed to be the first offender, no previous case is pending against him. He has permanent residence at JJR Nagar, Royapettah, therefore there is no possibility of flee from justice. Taking into consideration the period of custody, nature of allegations levelled against the petitioner, he seemed to be the first offender, no previous case is pending against him, stage of investigation and also considering the overall facts and circumstances of the case, this court is inclined to grant bail to the petitioner.

**8. In the result, this petition is allowed;** The petitioner/accused is

ordered to be released on bail on his execution of bond for Rs.10,000/- with two sureties for a like sum to the satisfaction of the District Munsif cum Judicial Magistrate, Pallavaram, with the following conditions:

1. The sureties shall affix their photographs and Left Thumb Impression (LTI) in the surety bond and the sureties shall produce a copy of any identity proof before the learned Magistrate to ensure their identity;
2. The petitioner/accused is directed to report before the respondent police station daily at 10.30 A.M. and 05.30 P.M. for a period of 30 days;
3. The petitioner/accused shall not tamper with the evidence either during investigation or trial;
4. If there is any breach of conditions, the Investigation Officer shall report to the learned Magistrate and the learned Magistrate shall take appropriate action as if the conditions have been imposed by the Magistrate himself/herself in accordance with the decision in *AIR 2006 SC 100 - P.K. Shaji Vs State of Kerala*.
