COMMITMENT ORDER:-

1. Accused above named have been forwarded by the SHO of Police Station Division No.8, Jalandhar to face trial for offence punishable under section 379-B, of Indian Penal Code, 1860 (hereinafter referred to as **IPC**).

2. As per prosecution story on 18.03.2017 ASI Ashwani Kumar, alongwith police party was present at Transport Nagar in connection with patrolling and checking of bad elements where a secret information was received to the effect that Deep, Rohit and Rohan had formed a gang and they collectively used to snatch purse and earrings of ladies in the market and on that day also they had committed snatching with a lady Kamaljit Kaur at Shiv Nagar and if raid be conducted they can be apprehended alongwith the snatched articles. On believing the information to be trustworthy ruqa was sent to the police station for registration of FIR. ASI Ashwani Kumar alongwith police party raided at the house of Deep and he was apprehended with the help of police party and was joined in investigation. During investigation he disclosed that he alongwith his friend Rohit alias Kaka and Rohan had snatched a purse of a lady at Mohalla Shiv Nagar and after snatching the purse all had gone back to their respective houses. He further disclosed that the snatched purse is in possession of Rohit alias Kaka and Rohan and the Activa on which the offence was committed belongs to Rohan alias Kaka. On the basis of the disclosure statement Deep was arrested and rough site plan was prepared and statement of witnesses were recorded. Thereafter, the

investigation of the case was handed over to ASI Sukhwinder Pal Singh and then to Kishore Kumar but the remaining accused Rohit alias Kaka and Rohan were not arrested. During investigation Rohit alias Kaka got anticipatory bail from the Court of Learned Additional Sessions Judge, Jalandhar and he was joined in investigation and during investigation he suffered a disclosure statement to the effect that on 18.07.2016 he alongwith Rohan and Deep had snatched the purse of a lady at Mohalla Shiv Nagar and the Activa on which the offence was committed was taken away by Rohan. The anticipatory bail application of Rohan was rejected by the court of the then Learned Additional Sessions Judge, Jalandhar and raids were conducted to arrest him but he was not arrested and proclamation proceedings against him were initiated. After completion of investigation, the challan against accused Deep and Rohit was presented in the court.

3. On appearance of accused in the court, copies of challan and necessary documents as relied upon by prosecution were supplied to Deep and Rohit free of costs as required under Section 207 of Code of Criminal Procedure, 1973 (hereinafter referred to as **Cr.P.C.**).

4. It is pertinent to mention here that accused Rohan did not appear in the Court and was declared as proclaimed person vide order dated 27.08.2018.

5. On close scrutiny of facts mentioned in Police report and documents appended with it, accused prima facie appears to have committed offence punishable under section 379-B of IPC. As the offence

punishable under section 379-B of IPC is exclusively triable by Court of Sessions, so this case is committed to the court of learned Sessions Judge, Jalandhar, for 21.09.2018. **Accused Deep and Rohit alias Kaka who are on bail are** directed to be appear before the court of learned Sessions Judge, Jalandhar on 21.09.2018 at 10:00 a.m. sharp. Order of commitment be notified to the Public Prosecutor, Jalandhar. Ahlmad of this court is directed to send the file, complete in all respects, to the court of learned Sessions Judge, Jalandhar well before the date fixed. File be revived as and when accused Rohan is arrested, surrender or appear before the court.
