Ld. P.P.-in-charge submits that the copies which are in the C.D. will be supplied to the accused persons and some documents are yet to be received from the concerned Department and copies of those awaited documents will be supplied to the accused persons after receipt of the same from the concerned Department after discussion with the I.O. of this case.

Ld. P.P. further submits that the coloured photographs are in the custody of the photographer and she will explore the possibility of handing over the digital photographs to the Ld. Counsels of the accused persons.

In view of the above fact and submissions, the hearing of the petition dated 10.03.2025 filed on behalf of the accused persons praying for cancellation of the scheduled dates for recording of evidence is adjourned today for the ends of justice.
