J U D G M E N T

The Sub-Inspector of Police, Tenali Rural P.S. filed charge sheet against accused in Cr.No.304/2022 for the offence under Sec.379 of Indian Penal Code and Sec.22 of MMDAR Act.

2. Accused is present and copies of documents furnished to him.

Accused is examined under Sec.239 Cr.P.C for the offence punishable under section 379 I.P.C against the accused are framed, read over and explained to him in Telugu, for which he pleaded guilty. He admitted the offence punishable U/sec.379 of IPC.
