**JUDGMENT**

The suit has been filed by the Plaintiff to grant permanent injunction restraining the Defendants, their men and Agents from in any way interfering with the peaceful possession

and enjoyment of 'A' schedule property and to grant Mandatory injunction directing the Defendants 6 & 7 to enter 1<sup>st</sup> Plaintiff's name in Natham 'A' register and to grant Permanent injunction restraining the Defendants their men and agents from any way interfering with the 2<sup>nd</sup> Plaintiff's peaceful possession and enjoyment of 'B' schedule mentioned property and to grant Mandatory injunction to enter 2<sup>nd</sup> Plaintiff's name in Natham 'A' register for 'B' schedule mentioned property and for costs.

On the side of the Plaintiffs, the Plaintiff is examined as PW1, and other witnesses were examined as PW-2 and PW-3, and Exhibits A-1 and A-2 were marked. The Defendants 1 to 9 having been called absent set exparte. The Plaintiffs by way of oral and documentary evidence has proved the suit claim.

In the result, this Suit is decreed as prayed for with cost.
