**ORDER**

1. This petition Filed U/s.483(b) BNSS Act to relax the condition imposed in Cr.M.P. 503/2025 dated 20.05.2025.

2. The petitioner submits that he was arrested in a case registered in Melmaruvathur Police Station Cr.No.145/2025, U/s. 303(2) BNS and remanded to Judicial custody on 30.04.2025 Thereafter, the petitioner/accused was enlarged bail in Cr.M.P.503/2025 dated 20.05.2025 with the condition that the petitioner shall appear and signed before the Respondent Police Station daily at 10.00 a.m

3. The petitioner further submitted that the petitioner was appear at the respondent police station on 22.05.2025 at 9.30 a.m as per the order of this Hon'ble court. Some of the local rowdy elaments were gathered and tried to assault the petitioner with deadly weapon when he appeared. The respondent police has not obtained signature from the petitioner and safeguarded him. The respondnet police station has also not given any protection to the petitioner. Hence, it is prayed this Hon'ble court may be pleased to modify the condition on the bail.

4. Heard. Records Perused. On perusal of records, it is found that the petitioner was arrested in a case registered in Melmaruvathur Police Station Cr.No. 145/2025 U/s.303(2) BNS and remanded to judicial custody on 30.04.2025. Thereafter the petitioner was enlarged bail in Crl.M.P. 503/2025 dated 20.05.2025 by the court with the condition that the petitioner shall appear and sign

before concerned police station every day at 10.00 a.m for 30 days without fail. Hence on considering the facts put forth by the petitioner, and the fact that the petitioner could not appear and sign before the respondent police station, the condition imposed in Clr.M.P.No. 503/2025 dated 20.05.2025 to appear and sign before concerned police station every day at 10.00 a.m for 30 days without fail is hereby modified.

5.Hence, the petitioner is also hereby directed to appear and sign before this court daily at 10.00 am for 30 days without fail.

6. The petitioner shall comply with all other condition of bail as previously imposed.

7. Therefore this petition is allowed.
