CLAIM: Suit filed under Order 7, Rule 1 and Section 26 of C.P.C. for recovery of an amount of Rs.12,18,986/- together with subsequent interest at 24% per annum on principal amount of Rs.7,50,000/- from the date of the suit till the date of realization, and for costs of the suit.

VALUATION: This suit is valued at Rs.12,18,986/- and a Court Fee of Rs.14,726/- is paid under Section 20 read with Article-I (b) & (c) of Schedule-I of the A.P.C.F and S.V. Act.

CAUSE OF ACTION: Cause of action arose on 15.02.2020 when the defendant borrowed an amount of Rs.2,00,000/- under bank transfer dated 10.02.2020 and further borrowed an amount of Rs.5,50,000/- in cash on 15.02.2020 and in token of receipt of the said amounts, in total Rs.7,50,000/- from the plaintiff, duly executed the suit promissory note, and all subsequent days of demands of plaintiff, personally and through mediators, the defendant issued a bounced cheque dated 11.10.2021 leading to issue of legal notice to the defendant and the suit promissory note transaction took place at Narsapur, Narsapur Mandal, W.G.District, which is within the jurisdiction of the Court.

This suit is coming on for final hearing before me on 20.12.2022 in the presence of Sri S.Rajeswara Prasad and Sri M.S.Joseph Raju, Advocates for the plaintiff and the defendant having remained *ex parte* and after perusing the material available on record and upon hearing arguments, this Court DOTH ORDER AND DECREE as follows:

1. that the suit be and the same is hereby decreed.
2. that the defendant do pay a sum of Rs.12,18,986/- (Rupees twelve lakhs eighteen thousand nine hundred and eighty six only) to the plaintiff together

with subsequent interest at the rate of 12% per annum from the date of the institution of the suit till the date of the decree, and thereafter interest at the rate of 6% per annum from the date of the decree till the date of realization only on principal sum of Rs.7,50,000/- (Rupees seven lakhs fifty thousand only).

3. that the defendant do also pay a sum of Rs.33,910/- (Rupees thirty three thousand nine hundred and ten only) to the plaintiff towards costs of the suit.
