Order No.36 dated 09.06.2025

Today is fixed for hearing of the petition dated 02.04.2025 filed by the Ld. P.P.-in-charge, production of the accused persons either in physical mode or in virtual mode and further cross-examination of P.W.1 namely Indrasen Shukla and cross-examination of P.W.2 namely Deepak Shukla and P.W.3 namely Kusum Devi.

The accused person nos.(A-1) namely Suryakant Tiwari and (A-2) Indira Tiwari are produced from the J.C. in physical mode.

Ld. Counsel appointed from the LADCS, Kolkata for the accused person namely Indira Tiwari is present by filing hazira.

Ld. Counsel for the accused person namely Suryakant Tiwari and the Ld. P. Ps.-in-charge are present.

Received one compliance report from the I.O of this case duly forwarded by O.C Jorabagan P.S stating that the two seized mobile phones were sent to the concerned authority for expert opinion and the CDR has been collected from the concerned authority in compliance of order of this Court.

Perused the same and let the same be kept with the record.

Photocopies of eleven photographs are supplied to the Prosecution with an endorsement "received" on the original photographs.

P.W.1 namely Indrasen Shukla is present in Court. He is further cross-examined by the Ld. Counsel for the accused persons **in full** and thereafter he is **discharged**.

The eleven photographs are marked as **"X" for identification collectively**.

As per Gazette Notification dated 15.07.2022, the certified true copy of the deposition of P.W.01 dated 09.06.2025 is handed over to both sides i.e. the prosecution as well as the Ld. defence Counsel after obtaining endorsement in the relevant register.

Ld. Counsel for the accused persons files a petition praying for a direction upon the Prosecution to serve copies of the call details record (CDR) of the relevant mobile connections to the accused persons on the ground stated therein.

Heard both sides.

In view of the above fact, the Prosecution is directed to serve copies of the CDR to the accused persons at once and also directed to file an acknowledgement receipt in this regard on the next date fixed.

Ld. P.P.-in-charge prays for issuance of summon upon the P.W.3 for cross-examination.

None moves the petition dated 02.04.2025.

Hearing of the petition dated 02.04.2025 is adjourned for the ends of justice.

Fixing **25.06.2025** and **26.06.2026** for production of the accused persons, hearing of the petition dated 02.04.2025 filed by the Ld. P.P.-in-charge and cross-examination of P.W.3 namely Kusum Devi.

The accused persons be remanded to J.C. till date.

Issue summons at once.

Requisites at once.

Let a copy of this order be sent to the I.O. of this case for information and necessary action.
