This cause referred to the Lok-Adalat organized by the Chennai District Legal Services Authority under Section 19 of the Legal Services Authorities Act (Act 39/1987) coming on before us for endeavors at settlement of the dispute between the parties, being the subject matter of this cause, in the presence of the parties and their counsel, and after a full and frank discussion of all issues factual and legal arising from the cause, the parties having agreed before us that there shall be an award / order / decree in terms of settlement here to made and the parties and their counsel herein having, in acceptance of the same signed this in our presence, it is decreed / ordered.

Both parties are present. On negotiation both parties have agreed for settlement of the dispute for a sum of Rs. 7,75,000/- (Rupees Seven Lakhs & Seventy Five Thousands Only)

The respondents is/are directed to deposit the settled amount before the competent court within six weeks from the date of this award, failing which the respondent's agreed to pay interest 7.5% per annum on the award amount from today till the date of deposit.

The dispute between the parties is settled accordingly. Therefore, the award is passed in accordance with the Sections 21/22 E of Legal Services Authorities Act 1987.

As and when the award amount is deposited in the court, the same shall be disbursed to the petitioner/s through NEET/RTGS, as per the directions of the High Court of Madras in CMANo.428/2016 in the bank account of the petitioner(s) as given below:
