எதிரி தரப்பில் எதிரிக்கு தமிழ் தெரியாது என்றும் ஆங்கிலம் நன்றாக தெரியும் என்றும் தெரிவித்ததால் எதிரி அளித்த சாட்சியம் பின்வருமாறு ஆங்கிலத்தில் பதிவு செய்யப்படுகிறது.

1. I am a senior citizen and also a retired soldier from Indian Airforce. Subsequently only I have joint Manito Electronics Limited as an Employee. I have joint as H R Manager (Senior Administrator). In same subject I have continued my research in Human Resource Development at BITS, Pilani. To do my reasearch I have relieved from the company by 1997. Also for purpose of reasearch I have obtained experience certificate from the company in the year 1998. As such directly I am not involved in the subsequent activities of the company. Nor signed any sort of

cheques or communications or agreement with TNPL. Photocopy of Approval Letter dated 12.05.1997 of BITS, Pilani is marked as **ExD6 (marked compared with original)**. Photocopy of Experience certificate issued by Manito Electronics is marked as **ExD7 (marked compared with original)**.

2) Manito Electronics Limited is a Public Limited company with equity participation of Kerala State Industrial Development Corporation (KSIDC). It is a Kerala State Government concern. And they are the real owner of the company and its properties even now. But unfortunately none of the directors of KSIDC are not seen or mentioned in this case. Even as a witness they were not shown. KSIDC as a Government concern also has not proceeded any thing against the directors of KSIDC, because KSIDC is a government concern and so if something wrong they would have taken necessary action. After this case all the directors went to Hon'ble High Court and Hon'ble Supreme Court also. In that case, in the list of directors my name was not there. Which shows that I am not anybody in the company that time.

3) Subsequently to safe guard myself I have produced all the evidence before Hon'ble High Court and expressed my grievance before Hon'ble High Court. Hon'ble High Court had quashed the case and relieved me from the case. Certified copy of Order of Hon'ble High Court of Madras in Crl. OP. No. 17916 of 2007 is marked as **ExD8**. This order has not been challenged also by anyone. Since I am not in the company and not involved in any sort of activities in then period, I was surprised how my name was added in this case. In view of the above I pray Hon'ble Court to kindly

consider my grievances and relieve me from this case. Photocopy of Incorporation Certificate consequent to change of name is marked as **ExD9**. Original of ExD9 is with the company and so original cannot be produced by me. Finally again I am stating that I am not the signatory to the cheque that has been mentioned in the case. Since it is a public limited company how the employees are responsible ? Actually in the public limited company supplier also have equal right like director and cannot deform or accuse the company.

4) Information I collected from the director shows that this cheque is a security cheque issued months before has been misused when the company was in strike. There is no evidence for the purchase for the amount mentioned in the cheque. There is no evidence of bill of purchase also. They could not produce any sort of documents.
