**ORDER**

The petitioner/accused has filed this petition to grant further some time to surrender for the anticipatory bail granted by this Court in V.Crl.M.P.No.71/2026, dated 13.05.2026.

The learned Counsel appearing for the petitioner/accused would submit that was not able to surrender before the Judicial Magistrate Court, Nilakottai within the time granted by this Court, due to his ill-healthiness; so he could not mobilize any sureties within a stipulated time; it is neither willful,nor wanton and hence prays to allow this petition and further time may be granted.

In the said circumstances, considering the fact, the petitioner's ill health, that this petition is allowed and time to comply the orders in Crl.M.P.No.71/2026, dated 13.05.2026 is extended and the petitioner is directed to comply with the condition within 15 days from this date of order and other conditions remains unchanged.
