as follows: -

That, you accused No.1 & 2 are the friends of deceased-Satish, 2 to 3 months prior to the incident, there was altercation held between you accused No.1 and deceased in respect of money transaction and in this regard, when you accused No.1 was not in your house, the deceased had been to your house and made Galata with your mother-CW.23 & sister-CW.24, due to this you accused No.1 had a grudge against deceased and also the deceased used to quarrel with you accused No.2 for silly reasons hence, therefore you accused No.1 and 2 hatched a plan with accused No.3 to 8, to commit the murder of deceased. That in consequent of said conspiracy, on 24.07.2020 at about 11:30 P.M., near Prabhakar Nagar on Sanskrati Colony road, Vijayapura within the limits of Adarsh Nagar P.S. you accused persons formed an unlawful assembly, being the members of such an unlawful assembly came in a Auto

bearing No.KA-28/D-6212, Pulsar Motorcycle bearing No.KA-28/EM-4747 and Splendor Motorcycle bearing No.KA-28/R-9089 by holding deadly weapons like Iron rod, Iron Sattur, Iron angle Patti and thereby you accused persons have committed the offences punishable U/Sec.143, 147 and 148 R/w Sec.149 of IPC and within the cognizance of this court.

Secondly, on the above said date, time and place, you accused persons being the members of unlawful assembly and in prosecution of such assembly, in Bagicha Dhaba situated at Vijayapura hatched a criminal conspiracy to murder the deceased-Satish and thereby you accused persons have committed the offences punishable U/Sec.120-B R/w Sec.149 of IPC and within the cognizance of this court.

Thirdly, on the above said date, time and place, you accused persons being the members of unlawful assembly and in prosecution of such assembly, wrongfully restrained the motorcycle of CW11 bearing No.KA-28/Q-1682 on which the deceased-Satish was pillion rider and thereby committed the offences

punishable U/Sec.341 R/w Sec.149 of IPC and within the cognizance of this court.

Fourthly, on the above said date, time and place, you accused persons being the members of unlawful assembly and in prosecution of such assembly, wrongfully restrained the motorcycle of CW11 bearing No. No.KA-28/Q-1682 on which the deceased-Satish was pillion rider; you accused No.3 thrown chilly powder on the face of deceased, due to which, when the deceased got down from the Bike, again you accused No.3 hold both legs of deceased; you accused No.1 assaulted deceased with Iron rod on his face & head, 3 to 4 times, you accused No.2 assaulted the deceased with Iron Sattur on his face & head; due to same, the deceased fell on the ground, and that you accused No.4 assaulted the deceased on his head and hand with Iron angle Patti, then you accused No.1 crushed the face of deceased with Stones and also you accused No.3 hit the head of deceased with a Stone and caused grievous injuries and thereby committed the murder of deceased-Satish and thereby committed the offences punishable U/Sec.302

R/w Sec.149 of IPC and within the cognizance of this court.

Lastly, on the above said date, time and place, you accused persons being the members of unlawful assembly and in prosecution of such assembly, you accused No.5, 6, 7 & 8 instigated and abated the other accused persons to commit the murder of deceased-Satish and thereby committed the offences punishable U/Sec.114 R/w Sec.149 of IPC and within the cognizance of this court.

And I hereby direct that you be tried by this court on the said charges.
