This petition came before this Court for final hearing today in the presence of Thiru.P.Sathish Kumar, the learned Counsel for the petitioner and of Thiru.T.Sivachandran, the learned Public Prosecutor for the respondent and heard either side and on perusing all the records, this Court delivered the following.....

ORDER

This petitioner / accused seeking for modification of the condition imposed in Crl.M.P.No.103/2026, dated 11.06.2026.

2. The learned Counsel appearing for the petitioner / accused would submit that this Court has already granted bail to the petitioner in Crl.M.P.No.103/2026, dated 11.06.2026 on condition that the petitioner shall appear and sign before the respondent Police daily at 10.00 a.m for a period of 2 weeks; that this petitioner is residing at Pushpathur Palani; that the petitioner abide the Court condition from 11.7.2026 to 16.7.2026; it is difficult him to follow this condition regularly and hence the condition may be modified.

3. On the side of respondent police reported that petitioner has aided the daily condition for 6 days.

In the above circumstances, considering the reason stated by the petitioner and in the interest of justice, this Court is inclined to modify the condition in Crl.M.P.No.103/2026, dated 11.06.2026 to the effect that, “the petitioner/ accused shall appear and sign before the Palani Town P.S. daily at 10.00 a.m., for the remaining period of 9 days without fail and other conditions remains unchanged.”
