This petition came up for hearing before me on 15.06.2026, Learned Assistant Public Prosecutor Grade -II appeared for petitioner and upon hearing petitioner side, pursuing the records, this court passed the following

ORDER

This petition filed U/s. 94 BNSS & 110 BNSS rules praying to direct the respondent to furnish the Registration details, Recovery Email, Phone number & IP logs of **smartpokketation@gmail.com** from 01.01.2022 to till date.

2. The learned counsel for the petitioner submitted that for misusing the Thainadu Finance Private limited by using Forgery app namely Wonder loan, case has been registered in Cr.No. 47/2022 U/s. 420 IPC, 66 C IT Act. The learned counsel further submitted that letter addressed to Google LLC seeking Registration details, Recovery Email, Phone number & IP logs of smartpokketation@gmail.com from 01.01.2022 to till date details. However the same was redirected by Google LLC 1600 Amphitheatre Parkway, Mountain view, California 94043 to Google Ireland limited Gordon House, Barroow Street, Dublin 4, Ireland. Google Ireland replied that with effect from 22.01.2019 Google Ireland Limited is

the controller responsible for the personal data of most of Google's consumer services. Hence for production of order from court. Hence Prays to allow this petition.

3. The point for determination is whether the petition allowable or not ?

4. Heard. Records perused. The case of the prosecution is on the complaint of Cyber Crime. Inspector A. Renuga Devi seeking action against the Forged App Wonder loan ID Creator. FIR has been registered in Cr. No. 47/2022 under section 420 IPC & 66C IT Amendment Act 2008. The records revealed that Investigation officer sent letter to the respondent on 26.01.2023 seeking user details of **smartpokketation@gmail.com**. However Google Ireland limited, Gordon House, Baroow Street, Dublin 4, Ireland requesting Court order to provide the Registration details, Recovery Email, Phone number & IP logs of smartpokketation@gmail.com from 01.01.2022 to till date. At this juncture, this application is filed seeking direction.

5. Considering the facts of the case, reasons stated, considering that **smartpokketation@gmail.com** user data is just and necessary for the investigating, considering that investigation is pending, Interest of justice, this court inclined to allow this petition.

In fine, for the above said reasons, this petition is allowed. The respondent Google Ireland limited is directed to furnish Registration details, Recovery email, phone numbers & IP logs of **smartpokketation@gmail.com** from 01.01.2022 to till date.
