ORDER

The case was registered under Cr. No.355/2022 of North Police Station, Erode for an offence punishable under S.18 r/w S.38(2) of The Unlawful Activities (Prevention) Act, 1967. This case is split up from the case in SC No.62/2023 as per the Order passed by this Court in Crl MP No.168/2025 in SC No.62/2023 dated 17.03.2025 and numbered as SC No.35/2025.

In SC No.62/2023 charge has been framed against the 1st accused Asif Musthaheen IM and is posted for the evidence of LW1.

Considering the circumstances of this case and the abscondence of the accused for a long period, I am satisfied that the accused is concealing himself from the process of court for the past more than 3 years, considering the fact that presumption under S.111 BSA is not automatic, I am satisfied there are materials to issue written proclamation in terms of Section 84 BNSS. Hence issue written Proclamation as against the accused for appearance on **23.02.2026** and the Complainant is directed to publicly read the publication in the conspicuous places namely Court premises, International Airport, Coimbatore, Office of the District Collector, Erode District, Notice Board of this court, Central Bus Stand and Solar New Bus Stand, Erode and Railway Station, Erode so as to requiring him to appear before this court on **23.02.2026 at 10.30 a.m.** and the Deputy Superintendent of Police, Special Investigation Division, Crime Branch CID, Trichy camp at Coimbatore is also directed to report the compliance.
