Originally the suit was filed before the Principal District Munsif, Bhavani and the case was taken on file as OS No.122/2021 and the suit was transferred to the file of Principal District Court, Erode as per the Order of Principal District Judge, Erode in Tr OP No.83/2025 dated 25.08.2025 and renumbered as OS No.638/2025 on the file of this court on 06.10.2025.

Suit for declaring the plaintiff is the legal heir deceased T.Venthan, Son of R.Thangamuthu who died on 24.05.2021 and restraining the 5th defendant, his men and agents from in any manner disbursing the death benefits of deceased T.Venthan (Employee No.5027 Sr.SSA) to the defendants 1 and 2 till the declaration of the legal heir of deceased T.Venthan by way of permanent injunction and directing the defendants to pay the costs of the suit to the plaintiff.

Date of presentation : Originally the plaint was filed on 26.08.2021 and 29.10.2021 before the Principal District Munsif, Bhavani and the same was received by transfer as per Order of this court in Tr OP No.83/2025 dated 25.08.2025 and renumbered as OS No.638/2025 on the file of this court on 06.10.2025.

Date of filing : The case was taken on file as OS 122/2021 by the Principal District Munsif, Bhavani on 01.11.2021.
The case was received by transfer and renumbered by this court as OS No.638/2025 on 06.10.2025.

Value of the suit : Rs.6000/- and a Court Fee of Rs.180/- has been paid u/s. 25(d) and 27(c) of the Tamilnadu Court Fees and Suits Valuation Act.

Details of Valuation

a) For the relief of Declaration

Since the relief claimed by the plaintiff for the declaration that the plaintiff notionally values the relief at Rs.5000/- and pays a Court Fee of Rs.150/- under Section 25(d) of the Tamil Nadu Court Fees and Suit Valuation Act.

b) For the relief of Permanent Injunction

Since the relief claimed by the plaintiff is incapable of valuation, the plaintiff notionally values the relief at Rs.1,000/- and pays the Court fee of Rs.30/- under section 27(c) of T.N.C.F.Act.

Value of the suit is Rs.6000/-

Court Fee paid is Rs.180/-

Cause of action for the suit arose on 03.12.1997, 24.05.2021, 28.05.2021, 22.06.2021, 06.07.2021 and on all subsequent dates at Bhavani, Erode District within the jurisdiction of this court.

DECREE

1. That the suit in OS No.638/2025 is dismissed as withdrawn.
2. That there shall be no order as to costs.
