ORDER

This Transfer Original Petition has been filed seeking to withdraw the suit in OS No.132 of 2021 pending on the file of the court of Learned District Munsif, Sathyamangalam and to transfer the same to the file of the court of Learned Subordinate Judge, Sathyamangalam for joint trial along with O.S No.188 of 2023 on the file of the court of Learned Subordinate Judge, Sathyamangalam.

03. **POINT FOR DETERMINATION:**

Whether the petition can be allowed?

04. POINT :

The petitioner has filed this petition seeking to transfer the case in OS No.132/2021 on the file of District Munsif, Sathyamangalam to the file of Subordinate Judge's Court, Sathyamangalam for trial along with the suit in OS No.188/2023 on the file of Sub Court, Sathyamangalam on the ground that the parties and the subject matter in both the suits are one and the same and to avoid multiplicity of proceedings, both the cases are to be tried by the very same court. The 8th respondent also endorsed no objection. Hence, this petition is allowed as follows as prayed for.

05. In the result,

(a) The transfer original petition filed by the petitioner in Tr OP No.224/2023 on the file of this court is hereby allowed,

(b) The original suit in OS No.132/2021 on the file of the court of District Munsif, Sathyamangalam is hereby withdrawn and transferred to the file of the court of Subordinate Judge, Sathyamangalam for trial with the original suit in OS No.188/2023 on the file of the court of Subordinate Judge, Sathyamangalam.

(c) It is left the decision of the Learned Subordinate Judge, Sathyamangalam to decide whether **both the cases are fit for joint trial or simultaneous trial** and the Learned Subordinate Judge, Sathyamangalam, is directed to proceed with the trial and dispose of the cases, in accordance with the law.

(d) The Learned District Munsif, Sathyamangalam, is hereby directed to transmit the records, duly indexed, in the original suit in OS No.132/2021 on the file of the court of District Munsif, Sathyamangalam to the court of the Subordinate Judge, Sathyamangalam, within two weeks from the date of receipt of this order, and

(e) Considering the nature and scope of this proceedings, there shall be no order as to costs.
