A petition has been filed on behalf of decree holder supported with an affidavit submitting therein that in present Execution Case 33/2023 has arisen for the enforcement and implementation of the Judgment and decree passed in Title (Partition) Suit No. 45 of 2015. The final decree was passed on the basis of the aforesaid report, map and tabulation chart submitted by the Pleader commissioner. Thereafter, for the purpose of giving effect to to the said decree by delivering actual and physical possession of the decretal property to the decree holders, the present execution case was instituted. It is also submitted that in the course of the execution proceeding, and in compliance with the writ of execution issued by this Hon'ble court, the Nazir of the civil court, Seraikella, with the assistance of the Government Amin duly delivered actual, physical and peaceful possession of the respective decretal shares in the property described in schedule-B to the plaintiffs/decrees holders. Since the decree has been fully and satisfactorily executed, and the decree holders have already obtained actual, physical, vacant and peaceful possession of the decretal property in terms of the decree, it is just proper and expedient in the interest of justice that this Hon'ble court may be pleased to record full satisfaction of the decree and dispose of the present execution case accordingly. Hence it is prayed to dispose of the present execution case by recording full satisfaction of the decree. Perused the record coupled with the Nazir report. From perusal of record, it is evident that the present execution case was filed by the decree holder for execution of decree passed in T (P) S. No. 45/2015 for granting possession over the decretal land. After going through the Nazir report as well as petition filed by the decree holder, there is no need to proceed with this case. Further more, as the decree holder has been satisfied with the execution of the decree. Hence under the facts and circumstances as mentioned above, it reveals that there is no chance of being prejudiced by either of the parties. Hence in the interest of justice, this execution case is hereby disposed off with full satisfaction.
