This condition Modification petition has been filed and came up for final hearing before this court in presence of Assistant Legal Aid defence counsel **Mrs.J.Kavitha learned Advocate for petitioner**, and **Mrs.N.Anitha, learned Assistant Public Prosecutor** for respondent and upon perusing the petition, records and objections and upon hearing both sides, this court delivered the following:

ORDER

Petition filed for condition modification, praying to modify the condition imposed in CrI.M.P.No.937/2026.

1. The petitioner in Crime Number.112/2026 of Erode Taluk police Station, Erode had submitted this application through his counsel seeking for condition modification stating that the petitioner got bail in CrI.M.P.No.937/2026 with the condition to execute a bond for Rs.10,000/- along with two sureties for the satisfaction of the court and the petitioner shall appear and sign before the respondent police station daily at 10.00 am for a period of one month. The petitioner is now residing at his grandmother's home which is within the limits of Poolampatti police station which is 60 kms from respondent police station. The nearest police station from his residential place is Poolampatti police station and it is very hardship to appear and sign before the respondent police station. The Petitioner prays to modify the

condition that to appear and sign before the respondent police station to Poolampatti Police station.

2. The learned Assistant Public Prosecutor who was forwarded with this application, has replied that the petitioner has been charged for offence U/s. 287, 296(b), 308(4) BNS in Crime Number.112/2026 of Erode Taluk police Station. The Petitioner is complying condition from 23.05.2026 to till date at morning 10.00 a.m. If the condition is modified the petitioner/accused may abscond and may commit the same kind of offence. Hence, the Prosecution strongly opposed to modify the condition.

3. Heard both sides. Records perused. Petition and objection are taken into consideration. The Petitioner has been arrested and remanded to judicial custody on 27.04.2026 for offence u/s. 287, 296(b), 308(4) BNS and released on bail and complying condition regularly from 23.05.2026 to till date at 10.00 a.m in the Erode Taluk Police station. Since the petitioner is residing at his grandmother's home which 60kms away from the respondent police station. Hence observing the reason the condition imposed in CrI.M.P.No. 937/2026 dated 18.05.2026 is modified to the extent that the petitioner shall appear and sign before the Poolampatti police station daily at 10.00 a.m for the remaining period as imposed in CrI.M.P.No. 937/2026 order dated 18.05.2026. The other conditions imposed in CrI.M.P.No. 937/2026 dated 18.05.2026 remains unaltered.

Accordingly, In the interest of Justice, the condition is modified as above and the petition stands allowed.
