Abdul Sattar and 3. Md. Ibrahim Miya.</b> A joint compromise petition has been filed on behalf of both the parties and a permission petition to compromise this case has been filed on behalf of the complainant. Copy of the same has been served to the Id. counsel of the complainant.</p> <p>Case called out. The accused-petitioners have appeared and taken into custody. Put up the record for evidence before charge. The attendance of the complainant has been filed as a witness. The evidence of the complainant has been recorded at the stage of <b>before charge</b> evidence.</p> <p>The <b>Charge u/s 498A of IPC</b> has framed and explained to the accused persons, in Hindi, to which they pleaded not guilty and claimed to be tried.</p> <p>The <b>evidence of the complainant</b> has been recorded at the stage of <b>after charge</b> and on the request of both parties evidence of the complainant has been closed and the record is fixed for recording the statement of the accused persons.</p> <p>The <b>Statements u/s 313 of Cr.P.C.</b> of the accused persons have been recorded today, to which they have denied the case of the Complainant and pleaded innocence.</p> <p>Heard both sides on the bail petition. It was submitted by the Id. counsel of the accused petitioners that petitioners are innocent and have not committed any offence rather they have been falsely implicated in this case. In this case the both the parties have compromised the matter out of the court and the complainant has no objection in grant of bail to the petitioners. The petitioners are ready to furnish sufficient local sureties, so they may be released on bail.</p> <p>On the other hand, the Id. cl. of the complainant has conceded the factum of compromise. The complainant Sahida Khatoon is also in physical present in the court and submits that the petitioners may be granted bail.</p> <p>Having consideration to the submissions, perused the case record, it is evident that the this is case u/s 498A of IPC, with allegation is that the accused persons have physically and mentally tortured the complainant for demand of dowry. But in this case, both the parties have compromised this case and also filed a joint compromise and permission petition to compromised this case.
