This cause referred to the Lok Adalat Organised by the Kallakudi District Legal Services Authority / Taluk Legal Services Committee under section 19 of the Legal Services Authority's Act (Act 39/1987) coming on before us for endeavours at settlement of the dispute between the parties, being the subject matter of this cause, in the presence of the parties and their counsel, and after a full and frank discussion of all issues factual and legal arising from the cause, the parties having agreed before us that there shall be an award / order / decree in terms of settlement hereto made and the parties and their counsel herein having, in acceptance of the same signed this in our presence, it is decreed / ordered.

Both parties are present. On negotiation, both parties have agreed for settlement of the dispute for a sum of Rs. 9,35,000 /- (Rupees Nine Lakh Thirty Five Thousand only)

The respondent/s is / are directed to deposit the settled amount before the Chief Judicial  
Magistrate, Kallakudi Court, Bank A/C No 42717536706, SBI  
Kallakudi, IFSC: SBIN0000852 within six weeks from date this  
 award, failing which the respondent/s agreed to pay interest 7.5% per annum on the award amount from today till the date of deposit.

The dispute between the parties is settled accordingly. Therefore, the award is passed in accordance with the Sections 21/22 E of Legal Service Authority's Act 1987.

As and when the award amount is deposited in the court, the same shall be disbursed to the petitioner/s through NEFT / RTGS, as per the directions of the High Court of Madras, in CMA No. 428/2016, in the bank account of the petitioner/s as given below:
