Both parties are present. On negotiation, both parties have agreed for settlement of the dispute for a sum of Rs. 3,80,000 /-(Rupees Three Lakh Eighty Thousand only)

The respondent/s is / are directed to deposit the settled amount before the Chief Judicial Magistrate, Kallakurichi Court, Bank A/C No 42717536706, SBI

Kallakurichi, IFSC: SBIN0000852 within six weeks from date this award, failing which the respondent/s agreed to pay interest 7.5% per annum on the award amount from today till the date of deposit.

The dispute between the parties is settled accordingly. Therefore, the award is passed in accordance with the Sections 21/22 E of Legal Service Authority's Act 1987.

As and when the award amount is deposited in the court, the same shall be disbursed to the petitioner/s through NEFT / RTGS, as per the directions of the High Court of Madras, in CMA No. 428/2016, in the bank account of the petitioner/s as given below:
