ORDER

Petition filed to pass an award/decrece directing the respondents to pay to the petitioner, the said compensation of Rs.15,00,000/- (Rs Fifteen lakhs only) with interest at 12% p.a jointly or severally from the date of accident till realization with costs to the petitioner.

Petitioner called absent no representation for long period. The petitioner not appeared before medical board also. Hence this petition is dismissed for default.
