directing the 4th defendant to issue legal heirship certificate accordingly and for the cost of the suit.

This suit came up before this Court on 29.09.2023 for final hearing in the presence of advocate Thiru. R. Chandrasekaran, the learned counsel for the plaintiff and the defendants set *ex parte* for non-appearance and upon hearing the plaintiff side and on perusal of records, evidence and having stood over for consideration till date, this Court doth order and decree as follows:

DECREE

1. That the suit be and the same is hereby partly decreed.
2. That the plaintiff alone is declared as the legal heir of the deceased Govindasamy.
3. The relief of declaration as against the defendants 1 to 3 is rejected and this suit is partly dismissed.
4. The relief of mandatory injunction directing 4th defendant to issue legal heirship certificate is refused and the suit is partly dismissed.
5. The plaintiff is directed to bear own cost of in the suit.
