the condition imposed on the petitioner previously.

ORDER

Heard both side. Perused the records.

2. Offences alleged u/s 126(2), 296(b), 115(2), 118(1) and 351(3) of
BNS.

3. The petitioner was granted bail by the Judicial Magistrate No.I, Nagercoil on 18.02.2026 in Crl.M.P. No.327/2026 with condition that the petitioner should appear and sign before the respondent police daily at 10.00 A.M. for a period of 30 days

4. The learned counsel for the petitioner submitted that the petitioner started to comply the condition from 24.02.2026. In the counter case in Crime No.37/2026, the accused Sekar was granted anticipatory bail by this court on 19.02.2026 in Crl.M.P. No.575/2026 with the condition that he shall appear and sign before the respondent police daily at 10.00 A.M. until further orders. Whenever, the petitioner go to comply with the condition before the respondent police, he is getting life threats from the accused in counter case. Therefore, the condition may be modified and permitted the petitioner to sign before any other police station in Tirunelveli or Tenkasi or Thoothukudi Districts.

5. The learned Public Prosecutor submitted that it is a case in counter and he has no serious objection.

6. Considering the reasons stated by the petitioner/accused and also the learned Public Prosecutor has no serious objection, this court is inclined to modify the condition.

7. In the result, condition imposed on the petitioner in Crl.M.P. No.327/2026 by the Judicial Magistrate No.I, Nagercoil is modified that the petitioner shall appear and sign before the Judicial Magistrate No.I, Tenkasi daily at

10.30 A.M. for a period of 30 days and accordingly this petition is allowed.
