Already this petition has been filed by Advocate Thiru Bergin Jeba Kumar, before the Vacation Sessions Court, Kanniyakumari at Nagercoil as Crl.M.P. No.239/2026, praying to relax the condition imposed on the petitioners previously and subsequently, it was transferred to this court and renumbered as Crl.M.P. No.1544/2026.

ORDER

No representation for the petitioner. Heard the learned Public Prosecutor. Perused the petition.

2. Offences alleged u/s 8(c), 20(b)(ii)(A), 25, 29(1) of NDPS Act and Sec. 123 of BNS.

3. The 1st petitioner/A1 was granted bail by this court on 30.03.2026 in Crl.M.P.No. 989/2026 and the 2nd petitioner/A2 was granted bail by this court on 30.03.2026 in Crl.M.P.No. 988/2026 with condition that the petitioners should appear and sign before the respondent police daily at 10.00 A.M. until further orders and subsequently, in respect of 1st petitioner, the condition was modified on 21.04.2026 in Crl.M.P. No.1289/2026 and in respect of 2nd petitioner, the condition was modified on 30.04.2026 in Crl.M.P. No.1428/2026 that the petitioners should appear and sign before the respondent police weekly once i.e. on every Monday at 10.00 A.M. until further orders.

4. It is stated in the petition that the 1st petitioner has been complying the modified condition from 27.04.2026 and the 2nd petitioner has been complying the modified condition from 04.05.2026 onwards and prayed that the condition may be relaxed.

5. The learned Public Prosecutor opposed the application and submitted that the 1st petitioner has been complying the modified condition from 27.04.2026 and the 2nd petitioner has been complying the modified condition from 04.05.2026 and the investigation is not yet over.

6. Considering the nature of the offences alleged to have been committed by the petitioners/accused and also considering the duration of compliance of condition and the stage of investigation, this court is inclined to modify the condition.

7. In the result, condition is modified that the petitioners shall appear and sign before the respondent police monthly once i.e. on 1st day of every month

at 10.00 A.M., until further orders and accordingly this petition is partly allowed.
