and upon hearing both side and upon perusing the materials available on record and having stood over for consideration till this day, this court delivered the following:

**ORDER**

Invoking Section 77(2) of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, the Collector has deposited a sum of Rs.9,68,272/- being the compensation payable to the land owner for the land admeasuring 0.01.74 Hectares in survey No.127/6 of Vadiveeswaram East Village, Agasteeswaram Taluk, Kanniyakumari District acquired under the said Act on behalf of Southern Railways by stating that though the patta stands in the name of one Ramanathan Chettiar, Sankara Kumarau Chettiyar, Kasinatha Muppanar, Shankara Narayanan Chettiyar and Akasaperumal Chettiyar as trustees of Kottar Chettu Thiruneelakanda Mutt Vagai, when notice was issued to the land owner, the trustees appeared before the Collector, but they did not file any title document in the name of the Mutt. Reckoning that there is no person competent to alienate the land, the amount has been deposited into CALA namely this court by a cheque.

2. The said reference has been taken on file as LAOP

No.124/2024.

3. The present trustees of the trust filed IA No.1/2025 seeking to implead themselves in the present reference and the same was allowed on 07.08.2025. Subsequent to this, they had filed the written statement making claim to the compensation amount. RW1 has been examined on behalf of the claimant and the Tahsildar concerned has been examined as CW1. Ex.R1 to Ex.R7 and Ex.C1 and Ex.C2 have been marked.

4. The only point that requires to be decided is whether Trustees of the Kottar Chettu Nainar Desiga Vinayagar Devasthanam can be said to be the persons entitled to alienate the property and consequently to receive the compensation under the proviso to Sec.77(2) of the RFCTLARR Act?

5. One Subramoniam has been examined as RW1 and has filed a proof affidavit stating that Nainar Desiga Vinayagar Devasthanam Trust, Kottar is being administered as per the scheme framed by the I Additional Sub Court, Nagercoil in OS 45/1094 M.E. marked as Ex.R1. In terms of bye-law 12 of the scheme, 5 trustees have to be selected by the trust members who shall manage the affairs of the trust for a period of 5 years. Pursuant to the order passed in EA No.3/2019 by the I Additional Subordinate Judge,

Nagercoil marked as Ex.R2, 5 trustees were elected and the said election results was confirmed by the I Additional Subordinate Judge, Nagercoil on 14.07.2020. Subsequently, another election was held on 07.12.2025 and the present respondents 6 to 10 namely V. Nagarajan, A. Chockallingam, Venkatesh, Ramachandran and Subramonian have been elected as trustees and the Advocate Commissioner appointed by the court to conduct election has filed his report before the I Additional Sub Court, Nagercoil on 09.01.2026. This report also has been accepted by the I Additional Sub Court, Nagercoil on 23.02.2026 in EA No.3/2025. This is ascertained by calling for the relevant records and perusing the same. A copy of order dated 23.02.2026 is also marked now as Ex.C2. Thus, it is clear that V. Nagarajan, A. Chockallingam, Venkatesh, Ramachandran and Subramonian, viz., the respondents 6 to 10 are the present trustees of Kottar Chettu Nainar Desiga Vinayagar Devasthanam Trust.

6. The patta in respect of the said property in the name of Kottar Chettu Thiruneelakanda Mutt Vagai has been marked as Ex.R3 and the settlement land register has been marked as Ex.R4. This has been reassured by examining the Tahsildar of the Taluk concerned as CW1 who has confirmed that the patta for the said property stood in the name of Kottar Chettu Thiruneelakanda Mutt Vagai. From Ex.R1, viz., the copy of the

scheme approved in AS No.450/1098 M.E., more particularly clause 1 of the scheme, it is seen that Nainar Desiga Vinayagar Pillaiar Kovil, Sasthan Temples, Mutharamman Temple, Thiruvambalam Muppanar Mutt, Thiruneelakanda Muppanar Mutt, Guruvara Mutt, Neeragara Mutt, Kumarakovil Mutt, Thiruchendur Mutt, Kanniyakumari Easanamoola Mutt and Kottar Pajana Mutt and the properties belonging to them are owned and administered by Kottar Chettu Nainar Desiga Vinayagar Devasthanam Trust.

7. On the basis of decree passed by the Travancore High Court in AS No.450/1098 M.E. (OS No.45/1094 ME on the file of I Addl. Sub Court, Nagercoil), a Scheme has been framed with regard to the Kottar Chettu Nainar Desiga Vinayagar Devasthanam.

8. In such circumstances, this authority is of the view that Ex.R3 patta and Ex.R4 copy of settlement land register establishes that Kottar Chettu Nainar Desiga Vinayagar Devasthanam is the owner of the property, which has been acquired under Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act and therefore, the compensation amount of Rs.9,68,272/- is payable to the Trustees of Kottar Chettu Nainar Desiga Vinayagar Devasthanam Trust, upon whom the trust properties vest as per law.

9. RW1 Subramoniam, one of the trustees who adduced evidence had stated that the said trust has savings account with Bank of Maharashtra, Nagercoil Branch in account No.60421623099 and the copy of savings bank account pass book has also been marked as Ex.R5.

10. In such circumstances, the award amount of Rs.9,68,272/- together with accrued interest, if any, shall be payable to Chettu Nainar Desiga Vinayagar Devasthanam, Kottar being the compensation amount payable to the said trust as per the award No.9/2023, dated 20.12.2023 in connection with the acquisition of land admeasuring 0.01.74 Hectares in Survey No.127/6 of Vadiveeswaram East Village, Agasteeswaram Taluk, Kanniyakumari District.

**11. In the result,**

(i) An amount of Rs.9,68,272/- deposited by the Collector into this court, together with accrued interest, towards compensation for the land admeasuring 0.01.74 Hectares in Survey No.127/6 of Vadiveeswaram East Village, Agasteeswaram Taluk, Kanniyakumari District acquired under Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 in Award No.9/2023, dated 20.12.2023 shall be paid to the Nainar Desiga Vinayagar Devasthanam, Kottar.

(ii) This amount is directed to be deposited into a nationalized bank as a fixed deposit for a period of three years, renewable automatically, in the name of the said trust, and the monthly/quarterly interest thereon shall be directly credited into the SB A/c No.60421623099 of the trust with Bank of Maharashtra, Nagercoil Branch and the trustees shall be at liberty to utilise the interest so received, for fulfilling the objects of the trust.

(iii) The amount lying in the fixed deposits shall not be withdrawn without the prior permission of this court.
