ORDER

1. Heard both the sides on bail application Exh.36. Considered the submissions. Accused is already granted bail. He is in custody in execution of NBW. On verification, the police have tendered report that he has a place of residence with his brother. On considering the

circumstances of case as an last opportunity, following orders are passed :

ORDER

1. Accused No.4 **Kamal Raju Ilabadi @ Ilavari** be released on furnishing P. R. Bond and surety of Rs.25.000/- (Rupees Twenty Five Thousand only) with one surety of like amount.
2. As an interim measure, accused be released on depositing cash bail of Rs.10,000/- (Rupees Ten Thousand Only) and he shall furnish surety within 4 weeks of his release.
3. The accused shall attend R.A.K. Marg Police Station on every fourth Monday between 11.00am to 01.00pm for a period of one year or as may be directed by this court.
4. Any default in attendance or breach of the earlier conditions will entitle the prosecution to pray for cancellation of bail.
5. Bail Application (Exh.36) is disposed off accordingly.
