JUDGMENT

The accused stands charge-sheeted for the offence punishable under section 303 (2) of the B.N.S.

2. The accused is in jail as an under trial prisoner. He was produced before the Jail Court. The accused voluntarily pleaded guilty as per the aforesaid plea. Hence, I proceed to pass the following order:-

ORDER

1. Accused namely **Rama s/o Machhindra Pawar** is convicted vide section 275 of the BNSS for the offence punishable 303 (2) of the BNS and he is sentenced to suffer Rigorous Imprisonment for 03 (Three) months and to pay fine of Rs. 3,000/- (Rupees Three Thousand only), in default of payment of fine the accused is sentenced to suffer Simple Imprisonment for 15 (Fifteen) days.
2. The period of detention, if any undergone by the accused during course investigation, inquiry or trial of the case, be set off against the term of imprisonment imposed on him vide section 468 of the BNSS.
3. The copy of this Judgment be given to the accused free of cost.
