Sole accused **Suklal Mardi** is virtually produced from the J.C.

The Ld. Spl. P.P.-in-Charge is present with one witness Mithu Shil.

Ld. Advocate Mr. Abul Kalam Azad for the accused files an application praying for surrendering his power.

The application is allowed.

Since, the advocate on record surrenders his power the accused is without legal representation and it will be necessary to appoint a lawyer for him on legal aid.

As the witness is present today it would not be proper to adjourn the matter solely for the purpose of intimating the Chairman SDLSC, Gangarampur at Buniadpur for appointment of Ld. Advocate.

Therefore, keeping in view the exigent circumstances **Mr. Sahajan Ali** who is present in Court is appointed as Defence Counsel for the accused **Suklal Mardi** with the consent of the Ld. Advocate.

This order of appointment is made in the interest of justice.

A copy of this order be send to the Ld. Chairman, SDLSC, Gangarampur at Bunaidpur requesting him to ratify the appointment of **Mr. Sahajan Ali** as Defence Counsel for the accused **Suklal Mardi**.

Copies in compliance of section 207 of the Cr.P.C are supplied to the Ld. Advocate **Mr. Sahajan Ali** on behalf of the accused.

The case is now taken up for evidence.

The witness Mithu Shil is examined as P.W.1 by the prosecution in full.

During the examination of P.W.1 documents are marked Exhibit P-1, P-2 and her LTI on the medical report is marked X for identification.

At this stage the Ld. Advocate for the Defence files an application U/S 254 of the BNSS. Copy served.

The application is taken up for hearing.

Heard both sides. Considered.

The application is allowed.

Considering that there is possibility of disclosure of defence, the defence may cross-examine P.W.1, CSW-2, CSW-3, CSW-4, CSW-5, CSW-6, CSW-7, CSW-8, CSW-9 and CSW-10 after all their examination-in-chief are completed.

Fix **07.06.2025** for evidence of **CSW-2, CSW-3 and CSW-4.**

Fix **09.06.2025** for evidence of **CSW-5, CSW-6 and CSW-7.**

Fix **10.06.2025** for evidence of **CSW-8, CSW-9 and CSW-10.**

Fix **11.06.2025** for cross-examinations of all witness examined.

The prosecution is directed to issue summons.

The true copy of the evidence-in-chief of P.W.1 in full be supplied to the Ld. Defence Counsel as well as Prosecution on proper verification and receipt.
