This suit has been filed under section 26 Order 7 Rule 1 of Code of Civil Procedure 1908 as amended by acts 104/1976 and 22/2002 and (A decree of declaration declaring the title of the plaintiff over the suit property;) (Amended as per order passed in I.A. 411/2016 dated 22.12.2016 and I.A. No.661/2016 dated 4.2.2017) and a decree for permanent injunction restraining the defendants their men, servants, agents or any one claiming under them from causing any sort of disturbances to the plaintiff's peaceful possession and enjoyment of the schedule property with cost. (The original A,B and C relief stands altered and Amended as B,C and D Relief as per order passed in I.A.No. 411/2016 dated 22.12.2016 and I.A.661/2016 dated 4.2.2017)

Cause of action for the suit arose on 21.05.1951, 26.10.1973, 20.05.1991, 17.07.2007, 27.08.2007, 24.09.2014, 30.09.2014, 07.10.2014 at Vadasery village within the jurisdiction of this court.

For the purpose of Valuation of Court fee and jurisdiction the suit 'A' (relief is valued as Rs. 75,000/- being the onehalf of the market value and a court fee of Rs. 5,625.50 is paid Under Section 25(b) of Tamil Nadu Court Fees and Suits Valuation Act XIV of 1955 and 'B') (Amended as per order passed in I.A.Mo. 411/2016 dated 22-12-2016 and I.A. No. 661/2016 dated 4.2.2017) relief is valued as Rs. 1,000/- and a court fee of Rs. 75.50 is paid under section 27(c) of Tamil Nadu Court fees and suit Valuation Act 14/1955. (Thus the suit is totally valued at Rs. 76,000/= and the total court fees paid is Rs. 5,701.00). (Amended as per order passed in I.A.No. 411/2016 dated 22.12.2016 and I.A. No. 661/2016 dated 4.2.2017)
