Suit is filed for recovery of Rs.98,268/-(Rupees Ninety eight thousand two hundred and sixty eight) from the defendants with future interest at the rate of 2% per month for the principal sum of Rs.98,268/-(Rupees Ninety eight thousand two hundred and sixty eight) from the date of suit and realization of the entire amount and other reliefs.

The cause of action arose at Cheruthikonam at Kulasekharam where the plaint transaction took place from 12.02.2018 to 08.01.2023 and 11.02.2023 being the date of dissolve of the self -help group and 13.04.2023 being the date of legal notice sent by the plaintiff to the defendant, oral demand by the plaintiff to the defendants and 28.10.2020 being the date of availing agricultural loan of Rs.50,000/- from the 4th defendants office, and 25.06.2021 being the date of waiving the agriculture loan announced by the government of Tamilnadu, and 13.04.2023 being the date of issuance of legal notice by the plaintiff's advocate and 15.09.2023 being the date of last demand by the plaintiff to the defendants all other subsequent dates on defendants failure to pay the amount arose at kulasekharam which is within the jurisdiction of this Hon'ble court.

The value of the subject matter of the suit for the purpose of jurisdiction and court fee is valued as Rs.98,268/- and a court fee of Rs.2948/- is paid under section 22 of amended Tamilnadu Court Fee and suit valuation Act 1995.

This suit is coming before me for final hearing in the presence of Mr.T.Glastin, learned counsel for the Plaintiff and Mr.T.Jeya Prasad, Learned counsel for the defendant D1 to D3 and Mr.V.R.Rajeswar. Learned counsel for the defendant D4. Upon hearing the both side counsel and on perusal of records having stood over for consideration till this day, this court doth decree as follows:-

DECREE

1. that the suit be and hereby is dismissed,
2. that there be no costs.
