And on 26.08.2020 being the date of statutory notice to the defendants and on 26.08.2025 being the date of Acknowledgment are well within the period of limitation. Cause of action arose at Karungal Village wherein suit property situated is within the territorial jurisdiction of this Hon'ble Court.

For the purpose of Court fee 'A' Relief is notionally valued at Rs.5000/- and fix court fee of Rs.100/- is paid under section 50(ii) of the suits valuation and curt fee Act of 1995, Tamil Nadu and the 'B' relief is valued as Rs.1000/- and a court fee Rs.30/- is paid u/s.27(c) of Tamil Nadu Court fees and Suits Valuation and Court fee act XIV of 1954.

This suit is coming before me for final hearing in the presence of Adv. T. Hubertson, learned counsel for the Plaintiffs and Adv. Government Pleader for the Defendants D1 to D5. Upon perusal of records stood over for consideration till this day, this court doth order and decreed as follows.
