Received the case record of Sonamura PS Case No. 2026 SNM 07 (NDPS) from the prosecution section along with charge sheet vide No. 70/2026 dated 04.08.2026 against the accused persons namely, **Akter Hossain, Mihir Alam, Saha Alam Miah, Matin Miah and Arif Hossain** u/s 21(C)/27A/29 of NDPS Act, 1985.

A separate prayer for custodial trial against all the arrested accused persons has submitted by the I.O. of the case.

Perused the charge sheet.

Register it as Special(NDPS) case.

Cognizance of the offence is taken under section 21(C)/27A/29 of NDPS Act, 1985.

Custody accused person persons namely, Akter Hossain, Mihir Alam, Saha Alam Miah and Arif Hossain are produced from J/C through VC.

Ld. Special P.P. is present.

Another petition has submitted by the Officer-In-Charge, Sonamura Police Station for passing necessary order for destruction of the seized remaining 192 nos. Phensedyl Cough Syrup (Triprolidine Hydrochloride & Codeine Phosphate & Cough Syrup)

bottles in one white color plastic sack and in one green color plastic sack without representative sample after inventory which are lying in District Go down.

Perused the same.

Keep it with the case record.

Heard both sides and considered.

Considering the prayer as submitted by the O/C, Sonamura PS is hereby directed to make necessary arrangement for destruction of the remaining seized contraband 192 nos. Phensedyl Cough Syrup (Triprolidine Hydrochloride & Codeine Phosphate & Cough Syrup) bottles in one white color plastic sack and in one green color plastic sack without representative sample through Drug Disposal Committee after observing all necessary formalities and also to submit report thereto.

Inform accordingly

One bail petition has filed for the accused persons namely Saha Alam Miah and Akter Hossain by their engaged Ld. Counsel Mr. S. Ali and prayed to release the accused persons on bail any condition.

Another bail petition has filed for the accused persons namely, Mihir Alam and Arif Hossain by their engaged Ld. Counsel Mr. J. Uddin to release them on bail imposing any condition.

Heard both sides.

Ld. PP raised strong objection against the bail prayer.

Perused the case record.

On perusal of the case record it appears that the offence alleged to have been committed involves commercial quantity of contraband items which attracts Sec. 37 of NDPS Act, and the stipulated period of 180 day's has not yet been over. I find no convincing ground to grant bail to the arrested persons.

Hence, the bail petition is stands rejected.

Custody accused persons namely, Aktar Hossain, Mihir Alam, Saha Alam Miah and Arif Hossain are further remanded to J/C till 13.08.2026.

Fix 13.08.2026 for production of the accused/ hearing on custody trial prayer/ order.
