This case was taken cognizence on **15.03.2018** by this court and which came up for hearing today in the presence of learned Assistant Public Prosecutor, Grade – I, representing the State and the Learned **Mr.S.Sunil** Counsel for A1, Learned **Tmt.S.A.Salini** Counsel for A2, this Court passes the following .

ORDER

The accused are present. They are charged with the offence punishable under section **392, 307, 506 Para two of Indian Penal Code 1860**, which is exclusively triable by **Hon'ble Court of Session**. The copies of police report and other documents as specified in section 207 of the Code of Criminal Procedure have been supplied to the accused. The case will have to be committed to the Court of Session.

Hence the order:-

1. That on appearance of Accused before this Court on **27.07.2026**, copies of documents relied on by prosecution were furnished to the Accused without delay and free of cost as per Section **207, Cr.P.C.**

2. Since the offence u/s. **392, 307, 506 Para two of Indian Penal Code 1860**, which is exclusively triable by **Hon'ble Court of Session**, the entire records and documents of this case is committed before the Court of Session as per Section 209(a) Cr.P.C.

3. The Accused is/are released on bail by order of Court. That as per Section 209(b) Cr.P.C, they shall continue to remain on bail and shall cause appearance without fail once the committed case is listed for proceedings before the Court of Session.

4. That the articles in **R.P.No.12/2017, R.P.No.27/2017** which are to be produced as evidence pertaining to this case is ordered to be produced without fail before the Court of Session (after the new number assigned and intimated to this court)as per Section 209(c) Cr.P.C.

5. That this order of commitment of the case to the Court of Session is ordered to be notified to the Public Prosecutor as per Section 209(d) Cr.P.C.

6. The registry is directed to submit the entire case records , Classification of witnesses Descriptive list of weapons/articles/property in any connected with the case. forthwith .

7. That when the Accused are questioned about the means to engage the Counsel, the Accused stated that they could engage counsel of their own to defend. Recorded .

The accused are directed to appear before the Hon'ble District Sessions Court, Nagercoil on **27.08.2026**
