This case was taken cognizance on **13.08.2025** by this court and which came up for hearing today in the presence of learned Assistant Public Prosecutor, Grade – I, representing the State and the Learned **Mr.M.Velkumar** Counsel for Accused, this Court passes the following .

ORDER

The accused is present. He is charged with the offence punishable under section **8(c), 20(b)(ii)(A), 25 Narcotic Drugs & Psychotropic Substances Act 1995 and 123 of The Bharatiya Nyaya Sahita 2023** which is exclusively triable by **Hon'ble Court of Session**. The copies of police report and other documents as specified in section 230 of the BNSS 2023 have been supplied to the accused. The case will have to be committed to the Court of Session.

Hence the order:-

1. That on appearance of Accused before this Court on **11.03.2026**, copies of documents relied on by prosecution were furnished to the Accused without delay and free of cost as per Section 230 of BNSS 2023.

2. Since the offence u/s. **8(c), 20(b)(ii)(A), 25 Narcotic Drugs & Psychotropic Substances Act 1995 and 123 of The Bharatiya Nyaya Sahita 2023** which is exclusively triable by **Hon'ble Court of Session**, the entire records and documents of this case is committed before the Court of Session as per Section 232(a) of BNSS 2023 .

3. The Accused is/are released on bail by order of Court. That as per Section 232(b) of BNSS 2023, they shall continue to remain on bail and shall cause appearance without fail once the committed case is listed for proceedings before the Court of Session.

4. That the articles in **R.P.No.90/2025** which are to be produced as evidence pertaining to this case is ordered to be produced without fail before the Court of Session (after the new number assigned and intimated to this court) as per Section 232(c) of BNSS 2023.

5. That this order of commitment of the case to the Court of Session is ordered to be notified to the Public Prosecutor as per Section 232(d) of BNSS 2023.

6. The registry is directed to submit the entire case records, Classification of witnesses Descriptive list of weapons/articles/property in any connected with the case. forthwith .

7. That when the Accused is questioned about the means to engage the Counsel, the Accused stated that he could engage counsel of his own to defend. Recorded .

The accused is directed to appear before the Hon'ble District Sessions Court, Nagercoil on **16.04.2026**.
