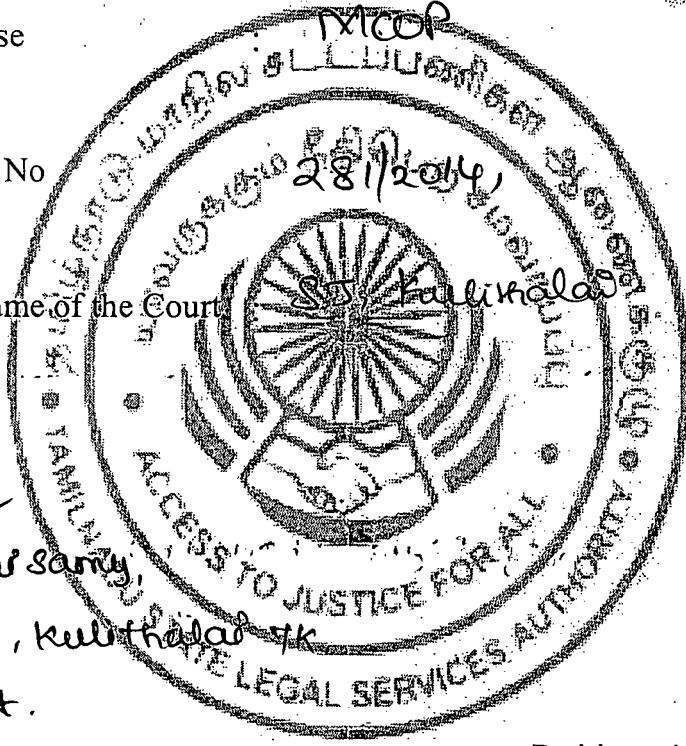

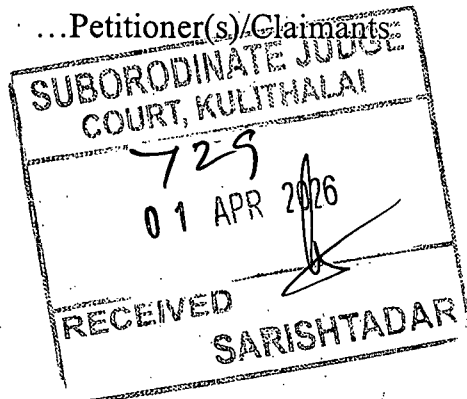

**Dispute in Brief:** The Claimant / Victim filed the application claiming compensation for the injuries sustained in the motor accident which occurred on 23/1/13 for sum of Rs. 50,000/- (Rupees Fifty Thousand only.) as compensation from the respondents.

**TERMS OF SETTLEMENT**

3) The respondent No. 02 agreed to pay a sum of Rs. 48,000/- (Rupees Forty Eight Thousand only) to the claimant/victim in full quit of claim.

4) The claimant/victim is entitled to the award amount of Rs. 48,000/- (Rupees Forty Eight Thousand only).

5) The respondent No. 02 have to deposit the entire settled award amount of the respective share of the claimant/victim within 4 weeks from the date of this award to the credit of the Bank Account of the claims Petitioner directly by NEFT or RTGS.

6) In default, the respondent No. have to pay interest at the rate of 7.5% per annum from the date of award.

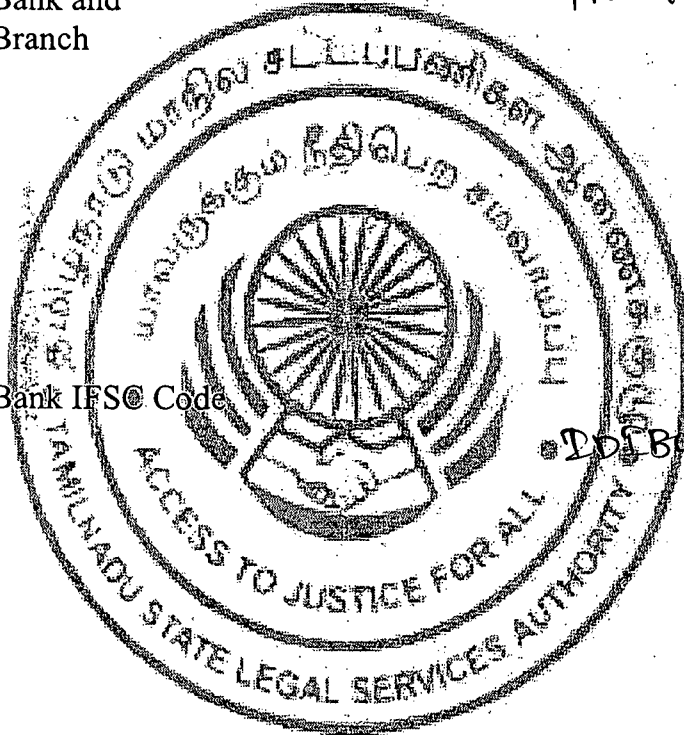



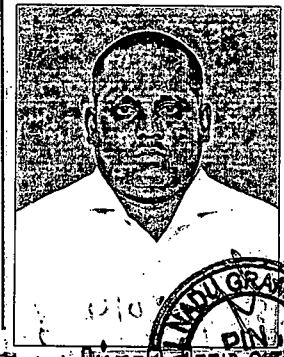
