This petition has come up for final hearing on 07.07.2025 before this Court in the presence of Thiru.A. Jaffar Shat, the Learned Counsel appearing for the Petitioner and the Respondents No.1,8 were died and in the presence of Thiru.R.Krishnasamy, the Learned Counsel appearing for the Respondent No.2 to 7 and in the presence of Government Pleader Thiru. K.S.M. Sahul Hameed, the Learned Counsel appearing for

the Respondents No. 9 to 11 and the Respondents No.12, 13 are called an absent set exparte upon perusal of material records and having stood over for consideration till this day, this court delivers the following:

ORDER

- 1) This petition is filed under Order 22 Rule 4 of CPC in order to implead the legal heirs of the deceased 8th Defendant namely Navaneetham in the above suit.
- 2) R1, R8 were already died. R12,R13 were already set exparte.

Brief averments in the affidavit are as follows:

3) The Petitioner is the Plaintiff in the above suit and the Executive Officer of Sakkalamman Temple and is the Zamindar. The above suit was filed by this Petitioner/Plaintiff against the Respondents/Defendants for the relief of declaration and for the consequential relief of Permanent Injunction and Mandatory Injunction. When the above suit was pending on 10.04.2024, the 8th Defendant in the above suit namely Navaneetham was died. The proposed parties as mentioned in the petition are the legal heirs of the deceased 8th Defendant and they have to be impleaded in the above suit as Defendants No.14 to 17 in the interest of justice. If this petition is not allowed, the Petitioner will be put to irreparable loss and hardships. Hence this petition.

Brief averments in the counter objection filed by the Respondents No.2 to 7:

4) The petition is not sustainable. The fact that the Petitioner is the Executive Officer of the above temple has to be proved by the Petitioner only. The averments stated in the paragraph No.4 of the affidavit of the Petitioner has to be proved by the Petitioner only. The number of days of delay caused was not correctly stated in the petition. Hence, this petition is liable to be dismissed.

Brief averments in the counter objection filed by the Respondents No.9 to 11:

5) The petition is unsustainable in law and on facts and the Petitioner is not entitled to the relief sought for in this petition. All the allegations contained in the petition are hereby denied and they are to be proved by the Petitioner only. The persons who were alleged to be the legal heirs of the deceased 8th Defendant in the above suit, has to be proved by the Petitioner only. This petition has been filed with much delay and without stating any proper reason . This petition has no prima facie. Hence this petition is to be dismissed in limine.

Evidence:

6) No oral and documentary evidence were adduced on either sides.

Points for Determination:

7) Whether the Petitioner is entitled to the relief sought for in this petition?

Discussion:

8) Heard both sides. Perused records. It is seen clear that on 27.08.2024, a memo was filed stating that the Defendant No.8 namely Navaneetham was died on 10.04.2024 and the above memo was recorded by this Court. After that, from the said intimation till 10.12.2024, no steps were taken by the Plaintiff/Petitioner in impleading the legal heirs of the deceased 8th Defendant in the above suit. Only on 10.12.2024, this petition has been filed. Even so, there is no denial on the side of the Respondents No. 2 to 7 herein as to the legal heirship status of the proposed parties in this petition. Also, the Respondents No. 9 to 11 herein have only evasively denied the legal heirship status of these Proposed parties rather making a specific denial. This court is of the view that the Plaintiff being the dominus litus of this suit, he is having every right to implead the legal heirs of the deceased Defendant in order to claim his relief against them, so that his right to claim

against the deceased Defendant will not be put to end and the same can be enforced against the legal heirs of the deceased. This apart, no person can be left enriched without any just reason and the Plaintiff/Petitioner has every right to implead the legal heirs of the deceased 8th Defendant and to proceed with the above suit. This court also feels that if this petition is allowed, it would no way prejudice the Respondents herein. Hence, this court is inclined to allow this petition.

Result:-

In result, for the reasons stated above and in the interest of justice, this petition is allowed. Hence, the Proposed Parties No.1 to 4 are hereby impleaded as the legal heirs of the deceased 8th Defendant Navaneetham in the above suit. No costs.
