This petition came up for hearing before me on 18.03.2026 in the presence of Mr.R.Sathiskumar, Counsel for the Petitioner and upon considering both side submissions and on perusal of records and having stood over for consideration till this date, this Court passed the following;

ORDER

This petition is filed by the Petitioner seeking a direction to the Garnishee to deposit the amount directly into her bank account, instead of remitting the same through Demand Draft before this Court.

2. Heard the both sides. Perused the records. It is seen that this Court had earlier passed a garnishee order in CrI.M.P. No.732/2022 dated 05.08.2022, directing the Garnishee, namely, The General Manager (Accounts), Salary Section, TNSTC (Kumbakonam) Ltd., Trichy, to remit the amount payable to the Petitioner from the Respondent's salary. Pursuant thereto, the Garnishee has been complying with the said order by depositing the amount of Rs.5,275/- before this Court through Demand Draft. The Petitioner has now sought for modification of the mode of payment, stating that direct credit into her bank account would avoid delay, facilitate immediate access to the amount, and reduce procedural inconvenience.

3. Considering the submission made and in order to ensure expeditious disbursement of amount to the Petitioner, this Court is inclined to allow this petition.

4. In the result, **this petition is allowed.** The Garnishee, namely, The General Manager (Accounts), Salary Section, TNSTC (Kumbakonam) Ltd., Trichy, is hereby directed to deposit the amount of Rs.5,275/-, directly into the below mentioned bank account of the Petitioner from the next month. The

Garnishee shall continue to deposit the amount on or before the due date every month, and file proof of such deposit before this Court periodically.
