CHARGE

I, Sri.Kiran Kini, I Addl. District and Sessions Judge and Spl. Judge, Haveri is hereby charge against you accused as under:

1. Firstly, on 30.07.2019 at about 11.30 a.m., at Hiremaralihalli village in front of Hiremaralihalli Gram Panchayat when the complainant and other villagers were gathered for protesting about acquirement of lands illegally by accused persons, all the accused persons, being

members of unlawful assembly, in prosecution of common object, in order to commit offence and thereby committed an offence punishable u/S.143 r/w 149 of IPC and within my cognizance.

2. Secondly, on said date, time and place, all accused persons, being members of unlawful assembly, in prosecution of common object, in order to commit offence of rioting and thereby committed an offence punishable u/S.147 r/w 149 of IPC and within my cognizance.
3. Thirdly, on said date, time and place, all accused persons, being members of unlawful assembly in prosecution of common object in order to commit offence, all the accused persons pulled, kicked and dragged complainant and CW-4 to 9 and caused hurt to them voluntarily and thereby committed offence punishable u/S.323 r/w 149 of IPC and within my cognizance.
4. Fourthly, on said date, time and place, all accused persons, being members of unlawful assembly in prosecution of common object in order to commit offence, all the accused persons dragged complainant and CW-4, 5, 6, pulled them and dragged their saree and assaulted them and outraged their modesty in public place and thereby committed offence punishable u/S.354 r/w 149 of IPC and within my cognizance.
5. Fifthly, on said date, time and place, all accused persons, being members of unlawful assembly in prosecution of common object in order to commit offence, all the accused persons pushed down CW-7 to 9 on the ground and tried to squeeze their neck and attempted to commit murder of them and thereby committed offence punishable u/S.307 r/w 149 of IPC and within my cognizance.

6. Sixthly, on said date, time and place, all accused persons, being members of unlawful assembly in prosecution of common object in order to commit offence, have abused complainant and CW-4 to 9 in filthy words and insulted them intentionally and thereby committed an offence punishable u/S.504 r/w 149 of IPC and within my cognizance.
7. Seventhly, on said date, time and place, all accused persons, being members of unlawful assembly in prosecution of common object in order to commit offence, have abused complainant and others by taking their caste as "ಎಸ್.ಸಿ.ಎಸ್.ಟಿ. ಸೂಳೆ ಮಕ್ಕಳೆ, ಮಾದರ ಕೀಳು ಜಾತಿ ಬೋಸಡೇರ " and disrespected Madar, Walmiki caste knowing that they are members of Scheduled Caste and Scheduled Tribe and thereby committed offence punishable u/S.3(2)(v), 3(1(r), 3(2)(va) of SC/ST (PA) Act, 1989 and Amended Act, 2015 and within my cognizance.
8. Lastly, on said date, time and place, all accused persons, being members of unlawful assembly in prosecution of common object in order to commit offence, all accused persons have given life threat to complainant and others and thereby committed an offence punishable u/S.506 r/w 149 of IPC and within my cognizance.

I hereby direct you be tried for said offences.
