### **1. Nature of Prosecution Case:-**

This is a case U/s 296(b), 115(2), 351(2) BNS. The brief case of the prosecution as set out in the final report U/s 173(2) Cr.PC is as follows: That On 20/10/2025, at about 16:20 within the limits of Uthappanaickanur P.S, when the defacto complainant went to Santhanamariamman temple function at U.Vadipatti, there was some dispute between the LW1 and the accused regarding firing of crackers. Due to which, both the accused abused the defacto complainant in filthy language and attacked him and pushed him to the ground and also attacked the LW2 with hands and caused Simple

injuries and criminally intimidated them and thereby the accused A1 and A2 committed an offence U/s 296(b), 115(2), 351(2) of BNS. Hence, the accused is charged.

## **2. Plea of the Accused:-**

On receipt of the final report, this court has taken cognizance of the offence U/s 296(b), 115(2), 351(2) of BNS. Thereafter summon was issued to the accused. On appearance of the accused, copies of the final report, statements and documents were furnished to the accused. Thereafter charges framed for the offences under sections U/s 296(b), 115(2), 351(2) of BNS and was read and explained to the accused. The accused pleaded not guilty and claims to be tried.

## **The Evidence**

### **The Prosecution Version**

3. The prosecution has examined **PW.1 to PW.5** and marked **Exp-P1 to Exp-P5** on their side. The prosecution has dispensed with the examination of LW4, LW5, LW7, LW8, LW9 and LW10, and examined additional witness as PW5.

4. The **PW.1** is namely Sathya, who is the defacto complainant in this case and she has deposed that she has entered into compromise with the Accused. She has given complaint against him with exaggerated facts. The said complaint is marked as **Exp.P1**. The police didn't examine her.

The PW1 was declared hostile and cross examined by the prosecution side.

5. The **PW.2** is namely Anand, who is the projected eye witness and he has deposed that the PW1 has entered into compromise with the Accused and She has given complaint against him with exaggerated facts and police did not examine him in this regard.

The PW2 was declared hostile and cross examined by the prosecution side.

6. The **PW3** is namely Kannan, who is the projected eye witness and he has deposed that the PW1 has entered into compromise with the Accused and She has

given complaint against him with exaggerated facts and police did not examined him in this regard.

The PW3 was declared hostile and cross examined by the prosecution side.

7. The **PW4** is namely Vellakannu, who is the projected eye witness and he has deposed that he knows nothing about the case and police did not examined him in this regard.

The PW4 was declared hostile and cross examined by the prosecution side.

8. The **PW5** is namely Thirupathy, who is the Additional witness examined by the prosecution and he has deposed by perusing the records about the registration of F.I.R, investigation done by the then investigation officer and filing of the final report by him. And he deposed that the then investigation officer after examining the witness, recorded their statements and after the completion of the investigation, filed the final report. The said F.I.R is marked as **Exp.P2**. The said observation Mahazar and Rough Sketch is marked as **Exp-P3 and Exp.P4**. The alteration report is marked as **Exp.P5**.

#### **Questioning under section 313 of Crpc.**

9. When the accused was questioned U/s.313 Cr. P. C pertaining to the incriminating evidence adduced against him, the accused denied the same as false. On the side of accused, no oral or documentary evidence was adduced.

#### **The point for determination:**

10 The point for determination is Whether the prosecution has proved the guilt of the accused for the offence U/s 296(b), 115(2), 351(2) of BNS beyond reasonable doubt?

#### **Analysis of evidence**

11. Though the prosecution in its list of witnesses has projected many witnesses on their side but have examined only five witnesses.

**12.** The charge against the Accused is On 20/10/2025, at about 16:20 within the limits of Uthappanaickanur P.S, when the defacto complainant went to Santhanamariamman temple function at U.Vadipatti, there was some dispute between the LW1 and the accused regarding firing of crackers. Due to which, both the accused abused the defacto complainant in filthy language and attacked him and pushed him to the ground and also attacked the LW2 with hands and caused Simple injuries and criminally intimated them and thereby the accused A1 and A2 committed an offence U/s 296(b), 115(2), 351(2) of BNS.

**13.** It is one of the defence of the accused that the accused were not the person, who involved in the said occurrence and that the prosecution has not proved the same. The defence has denied all the allegations levelled against the accused. While the defence has not adduced any evidence in this regard, it has relied on the cross-examination of the prosecution witnesses to demolish their credibility.

**14.** The complaint PW.1 the alleged victim has deposed in his chief examination that she has entered into compromise with the accused and has given complaint against the accused with exaggerated facts. She has not whispered about anything in favour of the prosecution case. The PW2 who is the projected eye witness has deposed that the PW1 has entered into compromise with the Accused and She has given complaint against him with exaggerated facts and police did not examined him in this regard and turned hostile to the prosecution.

**15.** The PW3 who is the projected eye witness has deposed that that the PW1 has entered into compromise with the Accused and She has given complaint against him with exaggerated facts and police did not examined him in this regard and turned hostile to the prosecution.

**16.** The PW4 who is the projected eye witness has deposed that he knows nothing about the case and police did not examined him in this regard and turned hostile to the prosecution.

17. The PW5 is the investigation officer in this case and he has deposed only by perusing the records about the registration of FIR, the investigation process and the filing of the final report. And there is no corroboration to the testimony of PW5. No other witness was examined by the prosecution to prove the guilt of the accused. In these circumstances it can be safely concluded that the prosecution had failed to prove the case against the accused beyond reasonable doubt.

18. The basic foundation of criminal law/ responsibility is that 'a person accused of an offence is presumed to be innocent till the guilt alleged as against him is proved beyond all reasonable doubts'.

19. As a necessary corollary, suspicion, however, strong or probable, may not take the place of legal proof and when graver the charge, greater should be the standard of proof. The distance between 'may be true' and 'must be true' is too long.

20. For the reasons afore recorded, this Court comes to the conclusion that the prosecution has failed to adduce clear, cogent and sufficient evidence to prove the guilt of the accused in this case, beyond all reasonable doubts. And in the absence of thereof, the Court cannot resort to conjectures, assumptions and probabilities to convict the accused and it also renders it unsafe to rely solely on the testimony of PW.5 to convict the accused.

21. In the above circumstances this court comes to conclusion that the **accused found not guilty for the offense U/s 296(b), 115(2), 351(2) of BNS.**

22. In the result the accused **found not guilty for the offense U/s 296(b), 115(2), 351(2) of BNS and Acquitted in exercising of powers under Section 255 (1) of the Cr.P.C** and the accused are set at Liberty. The bail bond executed by the accused shall remain in force for the period of six months from today under section 437- A Cr. P. C.
