Number of cases have been received by way of transfer in compliance of circular No. 1075-1114/CIS-Challans/ RHC/2025 dated 15.01.2025. Perusal of the

same reflects that majority of the cases pertain to the year 2019, 2020 and 2021. As of today, the total pendency of this court stands at 35000 (approximately).

Perusal of record reveals that before the transfer of these cases to this court, no proceedings have taken place. It is pertinent to mention that none has appeared in these challans and even the prosecution has failed to take any steps to either get these challans disposed of or get them properly prosecuted. This Court has been apprised that before transfer of such cases, multiple Lok Adalats have already taken place.

Since no proceedings have been undertaken for the last 4-6 years, there is no purpose in keeping these challans pending. These challans are only clogging the system and causing unnecessary burden to the State exchequer. At the same time, it will not be out of place to mention that the sword of prosecution can not be kept hanging on the accused indefinitely.

Moreover, reference may also be drawn to the letter dated 14.03.2024 bearing no. 114/Notice Branch/Traffic/HQ addressed to the then Chairman, Centralized Computer Committee as per which the challans for the period 01.09.2019 till 13.03.2020 have been effectively withdrawn on the directions of the then DCP/Traffic.

In the light of the aforesaid circumstances and in view of Section 281 of BNSS, the proceedings in the aforesaid cases is stopped. All the accused persons are **discharged** for the challaned offence.

Challans stand disposed of.

Original Documents, if any, impounded with the Traffic Circle be returned to the rightful owner as per rules.

File be consigned to Record Room as per rules.
