That both the parties have amicably settled their issues and now there is no dispute between them. Further submitted that he is willing and ready to furnish bail bonds if enlarged on bail. The prayer for bail has been strongly opposed by the Ld. APP appearing on behalf of the State. Heard both the parties and perused the record from which it transpires that the petitioner is named in the FIR, and investigation is still pending in the case. The allegation against the accused is that with the promise to marry the minor daughter of the informant kidnapped her.
