1. The cognizance of the offence is already taken by the virtual court and fine was proposed for summary disposal of case as per Section 208 of the Motor Vehicles Act, 1988. 4. Keeping in view the plea of guilt of offence by the violator, violator **is liable for violation u/s 115/194(1) of Motor Vehicles Act of 1988. Violator is sentenced to pay a fine of Rs. 9000/- and in default simple imprisonment of 7 days.**
5. Violator is directed to pay the fine amount of Rs. 9000/- on the web portal of the court i.e. <https://pay.ecourts.gov.in>.
