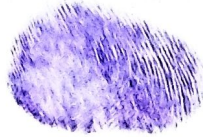
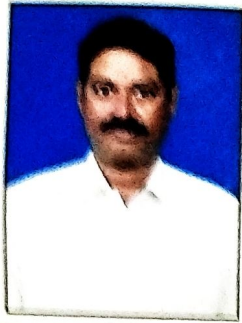
AWARD

The case is dismissed as settled before lokadalat and the accused is acquitted.

We the parties in the Lok Adalath proceedings have fully understanding the terms of settlement arrived and recorded as above. We have entered into the settlement voluntarily and not on account of any threat, coercion or undue influence. The settlement reached only before the Lok Adalath and not outside of the Lok Adalath.

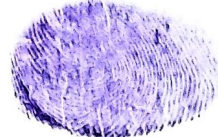

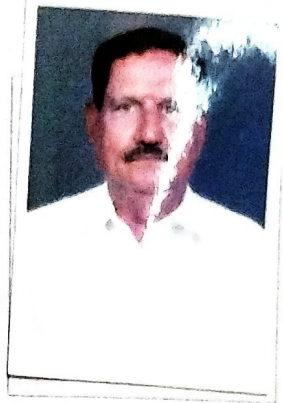
