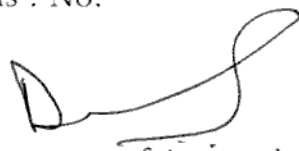

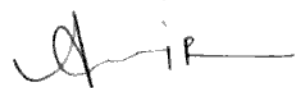

JUDGMENT

Accused is produced before Court. Particulars of offence is read over and explained to him. Accused pleaded guilty voluntarily. His plea is accepted as it is voluntary. Accused prayed for leniency. Ld. APP submits that maximum punishment may be imposed. Considering the submissions made by both sides, I proceed to pass the following order.

ORDER

- 1 Accused viz. **Desmond Agnello Jawar D'cunha** is hereby convicted for the offence punishable u/s. 185 of Motor Vehicle Act, as per section 252 of Cr. P.C.
2. Accused is sentenced to suffer S. I. till rising of the court and to pay fine of Rs. 10,000/- (Rs. Ten Thousand Only) i.d. to suffer S.I. for 7 days.
3. His bail bonds, if any, stand cancelled. The amount of cash surety, if any, be refunded to the accused forthwith.
4. Copy of the order be given free of cost to the accused.
