:-ORAL ORDER:-

1. Applicant/accused No.2 **Premal Vijaykumar Thanawala**, has filed the present application for extension of time to furnish surety. According to him, he has arranged a surety but the minor compliance has not completed, hence, he is seeking four weeks time for compliance.

2. The applicant filed surety application along-with all the necessary documents before the Registrar and the same is pending for document verification of surety. Further, the applicant submits that due to unavoidable personal and medical exigencies, the applicant has not furnished the surety till now. Hence, he prayed to grant four weeks time for complying with the procedures of surety.

3. Ld. P.P. for the State resisted this application on the grounds that sufficient time is already granted to the applicant.

4. Perused the Bail Order dtd. 28.10.2025. It is pertinent to note that the applicant/accused was granted bail under condition that the applicant/accused be released on bail on execution of Personal Bond of Rs.25,000/-with furnishing solvent surety of like amount. After going through the submissions of both the parties, I found that minor compliance is necessary and therefore, extension of time till next date is sufficient. Therefore, I proceed to pass the following order.

ORDER

1. Application (Exhibit 15) is allowed.
2. Applicant/accused No.2 **Premal Vijaykumar Thanawala**, is hereby granted time till next date to furnish surety, as a very last chance.
3. Application (Exhibit 15) is accordingly disposed off.
