(b) *That the petitioner/plaintiff is permitted to tender Document Nos. 3 and 4, namely, (i) the Xerox copy of the CSR Receipt issued by the G1 Police Station and (ii) the Xerox copy of the Letter received by the 1st defendant from the Joint Director, Udhagamandalam, as secondary evidence, subject to proof of their execution, genuineness, relevancy and admissibility in accordance with law. The mere marking of the said documents shall not, by itself, amount to proof of their contents.*

(c) *That there shall be No order as to costs.*
